OFFICE ORDER

An order dated 08.01.2026 has been passed by the Hon'ble High Court in the matter W.P. (C) 3903/2017, CM Appl. 18718/2017, 19134/2017 & 27526/2018 wherein the following direction was issued for compliance:-

**Direction-1 :-** *It is therefore, clear that all persons who wish to avail of health facilities in Delhi would now be entitled to take benefit under the EWS criteria of Rs. 5,00,000/-, upon satisfying the necessary pre-conditions. The said enhancement would apply to all government hospitals across Delhi and all identified Private Hospitals built on land allotted at concessional rates, where the EWS norms are applicable. This court takes this enhanced EWS criteria on record and directs that adequate publicity be given to the enhancement so that the citizens are made aware of the same and take benefit*

All HoDs of Government Hospitals of GNCT of Delhi / M.S. of All Identified Private Hospitals & CDMOs of all Districts are hereby directed to comply with the directions of the Hon'ble High Court to display the enhanced income criteria for EWS eligibility under the scheme properly.

Further, at least 02 boards of 10x6 feet should be installed in the premises of all Government Hospitals falls under the jurisdiction of Govt. of NCT of Delhi and all Identified Private Hospitals to aware the general public to avail the benefit under the scheme. The Government Hospitals falls under the jurisdiction of Govt. of NCT of Delhi and all Identified Private Hospitals are also directed to display the same on their official website and submit compliance report.

All CDMOs are directed to monitor the directions issued by the Hon'ble High Court regarding adequate publicity in respect of enhancement of the income criteria in the scheme and submit a compliance report of Government / Identified Private Hospitals falls under their jurisdiction accordingly within two weeks.

सरकार द्वारा चिन्हित निजी अस्पतालों को रियायती दरों पर भूमि उपलब्ध कराई जाती है, जिसके चलते माननीय सर्वोच्च न्यायालय/माननीय दिल्ली उच्च न्यायालय/दिल्ली सरकार के आदेशों के अनुसार, 25% ओपीडी और 10% आईपीडी निशुल्क सेवाएं चिन्हित निजी अस्पतालों द्वारा प्रदान की जा रही हैं। यह भी सूचित किया जाता है कि दिल्ली सरकार द्वारा ईडब्ल्यूएस के लिए चिन्हित निजी अस्पतालों में निशुल्क इलाज प्राप्त करने की आय सीमा 2,20,000/- रुपये से बढ़ाकर 5,00,000/- रुपये कर दी गई है।

Lands on a concessional rates is provided to the Identified Private Hospitals by the Government due to which by orders of Hon'ble Supreme Court / Hon'ble High Court, Delhi / Delhi Government, 25% OPD and 10% IPD free services are being provided by the Identified Private Hospitals. It is also informed that the annual Income limit for getting free treatment in identified private hospitals for EWS has been increased from 2,20,000/- to 5,00,000/-
