GNM COURSE ADMISSION PROCEDURE

General Nursing & Midwifery Programme is for a period of three years. Course of instructions and number of hours are as per requirements of the *Indian Nursing Council*.

ESSENTIAL ELIGIBILITY CRITERIA:

I. The minimum age for admission is **17 Years** (as on 31st December 2026)

II. 10+2 passed with **Science/Commerce/Arts** with aggregate of 50%. Any best **Four** subjects from the list are considered for calculation of percentage.

IV. The candidate must have passed English at 10+2 level by examination board /qualifying board.

V. Admission Criteria

- All the eligible candidates will have to go in 3 stages
 - Written Entrance Test\
 - Counselling/Interview
 - Medical Examination.
- Only those candidates who pass in written entrance examination will be called for the counselling/interview on merit basis.
- All relevant certificates, marksheet and other documents will be verified in original at the time of counselling/interview.
- Final list of selected candidates according to the merit will be displayed after counselling/interview.
- Submission of Fees
 - Successful candidates will be required to undergo a medical examination in the Sir Ganga Ram Hospital. Those found medically fit, would be admitted to the GNM course.
- Accepting terms and conditions mentioned in the prospectus.
- 10+2 certificate verification from concerned examination board/university/authority.

VI. Confirmation of Admission will be done on the basis of fulfilling the Admission Criteria.

VII. REASONS FOR REJECTION OF AN APPLICATION OR ADMISSION

- The candidate's admission shall be liable to rejection if any discrepancy is detected in the application form pertaining to age, even if it is less by a single day.

- Marks secured in the **10+2** examination shall not be rounded off to the next higher integer, even by a fraction, and even if the candidate has qualified in the entrance test and that admission has been confirmed through issuance of an admission letter.
- Further, any error or omission in the processing or verification of the candidate's certificates/documents, or the discovery of any discrepancy in information at any stage, shall render the admission liable to cancellation by the school/hospital authorities
 - False or incorrect statement made by the candidate.
 - Fraudulent means used by the candidate for getting admission.
 - False, unauthentic document attached to the admission application form.
 - Enrollment in any other full time/part time academic training/course.

VII. FOREIGN STUDENTS: The entry qualification equivalency i.e. **12th** standard will be obtained by University Grants Commission (**UGC**).

I. IMPORTANT INFORMATION

- The institution will not be responsible for any delay or non-receipt of application form.
- Candidates getting compartment in their 10+2 qualifying examination are entitled to get admission only on clearing failed subjects before counselling.
- Candidates withholding information of any sort will not be entitled for refund of fees after cancellation of their admission.
- Candidates awaiting copies of mark sheet or any other document required to be submitted to get admission, may submit the same within the dates notified in the prospectus.
- Canvassing/Approaching for admission in any form will entail rejection/cancellation of application form/admission/entry to examination hall.
- All the matters of dispute shall be subject to Delhi Jurisdiction.

Total amount of fee can be paid in 3 installments as under:

First Year ₹ 1,00,000/- (At the time of admission)

Second Year ₹ 1,00,000/-

Third Year ₹ 1,00,000/-

- Fee should be deposited by **July 31** (Every Year).
- ₹ 100/- per day will be charged as late fee after **July 31**.

In addition to the above:

- In case of failure of a student to pay the above mentioned fee/or charges before the due date of payment as fixed by the management, the admission of the student concerned shall automatically deem to be cancelled.
- Examination fee and Registration Fee shall be charged as prescribed by Delhi Nursing Council.
- Discontinuation of course is permitted up to **10th August, 2026** with refund of fee.
- **IN CASE STUDENT APPLIES FOR DISCONTINUATION OF THE COURSE AFTER AUGUST 10, 2026 THE ENTIRE AMOUNT PAID AT THE TIME OF ADMISSION WILL BE FORFEITED.**

- In case of fake certificates, the admission stands cancelled & no refund of fee will be made.
- The expenditure for the prescribed uniform and the books shall be borne by the student concerned.
- The above mentioned fees are subject to change.

After successful completion of course students will be provided with service placement within the hospital (subject to availability of the vacancy). They will be given an exposure to work in Super Speciality departments of the hospital and gain excellence in their performance at par with global standards.

EXAMINATION

Student shall be eligible for admission to the **Delhi Nursing Council Examination** if the Principal of school of nursing certifies the following:

1. She has completed not less than **eleven months** of the course.
2. She has minimum **80%** attendance in theory & practical in each subject separately during the academic year, however the **total clinical/field experience** prescribed must be completed **before the final** council/board examinations and before the issue of diploma. (The diploma shall not be awarded to the students till she has completed the clinical/field requirements).
3. The overall performance of the student and her conduct during the entire academic year has been satisfactory.
4. The student should pass in the internal assessment examination by securing **50% marks** in **each subject** i.e. both in theory and practical separately and students should complete required assignments of the academic year.
5. The Competency Record Book should be completed.
6. The **Principal** shall send the internal assessment marks to the council. Issuance of roll number will be at the discretion of **Delhi Nursing Council Examination Body**.

LEAVE

- Students are entitled for **30 days** Annual Leave.
- No other leave shall be granted other than immediate sibling's marriage or acute emergency in the family.

STUDENT NURSES ASSOCIATION

Students have an organisation of their own which is affiliated to Student Nurses Association of India and further affiliated to Trained Nurses Association of India. The students are encouraged to participate in the activities, thus accept leadership roles.

HOSTEL ACCOMODATION & MESS

- Hostel accommodation is available on request. Students from outside states will be given preference.
- The students who are provided hostel accommodation (as per availability) have to pay mess charges ₹ 2800/- by **10th of every month**.
- The amount is subject to change according to hospital policy.
- The mess is managed by the contractor under the direction of Principal, School of Nursing.
- Those provided hostel must follow all rules and regulations of the hostel.
- Facilities for indoor & outdoor games are provided.

GENERAL RULES & REGULATIONS FOR HOSTEL

- Students are responsible for the care of furniture and for cleanliness of their own room.
- Students should be properly dressed when going to dining room.
- Meals will only be served in the dining room at fixed timings.
- No meals will be allowed in the rooms.
- While leaving their rooms, students should check that lights, fans & switches are turned off. No radio, Tape Recorder, Heater or Electric appliances are allowed in the rooms. If found, a fine will be charged.
- Students are advised not to keep heavy cash, gold jewellery, costly electric items in their hostel room. If there is any damage or loss, the authorities will not be held responsible.
- Relatives/Visitors can meet the student between **5 pm - 7 pm**. No visitors will be allowed in student's room.
- Students should punch their incoming & outgoing biometric attendance daily.
- While going out of the hostel and coming back, student must sign in the outgoing register kept for the purpose. Students are not allowed to sign for any other student.
- Overnight & outgoing passes will be given at discretion of the authorities. Such passes will be issued every weekend and on Gazetted Holidays. This facility is liable to be withdrawn as disciplinary measure e.g. poor results, negligence in ward work, going out without permission.
- At **7 pm** there will be night attendance by Warden. All students are expected to be present for attendance. If anyone is found roaming after 7 pm in the hospital or outside, action as warranted will be taken.

- Students are representative of school and thus, are expected to set a high standard of behaviors.
- Trainee will follow rules of institution strictly. Non-observance of rules may lead to rustication. Disobedience and negligence of duty will be viewed very seriously. The defaulter is liable to be punished and if she does not improve, may be expelled from the training.
- Students are not allowed to continue any other Academic Training/ Course during their training period in this hospital.
- Use of **Mobile Phone** is not allowed in classrooms and clinical areas.
- Students are strictly prohibited from posting any content on social media platforms that may harm the reputation of the institute for the nursing profession.

The above rules are subject to amendment in the interest of trainees.

MEDICAL FACILITIES DURING TRAINING

- Students will be provided with medical facility by the hospital through Mediclaim up to the limit of ₹ **One Lakh** between **August 01, 2026 to July 31, 2029**) only.

DRESS CODE

- Students should be in approved uniform during training hours in clinical areas.
- Students are required to wear/display their Identity Cards issued by the hospital.
- Students should not wear any valuable jewellery/accessories/make up during training hours.

TERMINATION OF TRAINING

Training of student nurses will be terminated under the following circumstances:

- Failure to complete or fulfill the Theory and Practical requirements as per **Delhi Nursing Council/ Indian Nursing Council guidelines** for reasons other than illness or disability.
- In case of grave misconduct.

Ragging in any form is TOTALLY BANNED. If anyone found guilty, will be liable to punishment.

UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institution 2009

Clause 3: What constitutes Ragging?

1. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
2. Indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
3. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
4. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
5. Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
6. Any act that affects the mental health and self-confidence of a fresher or any other student.

Clause 7 & 9 – Administrative action can be taken by the institution in the event of Ragging

9.1 The institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed hereinunder

(A) The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, namely:

- i. Suspension from attending classes and academic privileges.
- ii. Withholding/withdrawing scholarship/fellowship and other benefits.

- iii. Debarring from appearing in any test/examination or other evaluation process.
- iv. Withholding results.
- v. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc.
- vi. Suspension/expulsion from the hostel.
- vii. Cancellation of admission.
- viii. Rustication from the institution for period ranging from one to four semesters.
- ix. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
